F) The Dawson Mill Pond and Sylvan-Otter Lakes are controlled by the Price Dam.

G) Crystal Lake is controlled by the Walter Moore Dam.

H) Lake Louise and Huff Lake are controlled by the Ruth Johnson Dam.
