Hi Jim,

Circuit Court would like to request an immediate e-vote from the Courts Leadership Group to send the attached Scope and Approach and ROI to IT for sizing.

This project is called Judge-On-Line and is a court-wide teleconferencing system designed to improve court scheduling options and speed up case resolution. We intend to pilot it with 5 judges and then expand to 19 a little later down the road. Once implemented, all circuit judges will have the ability to handle matters such as motions, conferences, and pre-trials over the phone with multiple parties connected.

This is a very important project to our judges and is on a very fast track. We were very conservative on the ROI but this could have significant ROI. Any questions please let me know.
