## NEW CIVIL FEE INCREASES EFFECTIVE MARCH 1, 2016

As a result of Public Act 231 of 2015, **civil filing fees are increasing as of March 1, 2016**. The new legislation requires the court to collect an “electronic filing system fee” in addition to the filing fees for commencing a civil action, whether or not the document commencing the civil action was filed electronically.

New fees:

- \$5 for civil actions filed in the small claims division of the district court
- \$10 for civil actions filed in the district court, including summary proceedings actions
- \$20 for civil actions filed in the district court if a claim for money damages is joined with a claim for relief other than money damages
