### Portable Testing Device

- 1) Contact an agency on the back of this sheet within 24 hours of appearing in court to pick up a unit. **You must have the unit within 72 hours.** Testing will begin immediately after you pick up the unit. You must notify the court within 24 hours of obtaining the testing unit which agency you have selected for testing. If you wish to change testing agencies, court approval is required.
- 2) The fees assessed with the Portable Testing Device are **your** responsibility; they are not included in the fines and costs assessed by the court.
- 3) All testing must take place between the times specified on your court/probation order, no exceptions.
- 4) Bond Clients: You must obtain a cellular based alcohol monitoring unit.
- 5) Please bring the following with you:
  - a. A picture ID. If you do not have one, please speak with a clerk or a Probation Officer
  - b. A copy of your sentencing/probation order.
- 6) You have been ordered to refrain from alcohol and/or alcohol products. While using a portable testing device, please refrain from smoking, brushing your teeth, using mouthwash, eating or drinking for 15 minutes prior to testing. If you test positive on the portable testing device, and cannot submit a negative test within 15 minutes, it is your responsibility to submit to an ETG test within 12 hours. If you fail to submit to an ETG during that time, the court will assume the positive test was valid. An alcohol product is defined as anything that contains alcohol; therefore, it is your responsibility to read all labels before eating or drinking. Some examples are mouthwash, toothpaste, liquid cold medicine, some liquid capsules and food.
