### Welcome and Introductions

- Meeting commenced at 2 PM and introductions were made.

### General Discussion on SoS Pilot

- SoS Feedback – Tina will find out the number of people who participated in the pilot.
- Robert from Kalamazoo stated there was only one discrepancy with a client, and they sent 15 people through the pilot program.

### Statewide Advocacy Efforts for ID

- Status of White Paper on ID & State Vital Documents
  - A rough draft White Paper on ID/Vital Documents' barriers based on 2016 White Paper by the Michigan Commission on Community Action and Economic Opportunity, the MCAH survey and the presentation to ICH by Debra Hendren and Elizabeth Kelly has been created and is being edited. This paper is expected to contain recommendations for resolution to some of the ID/vital documents' barriers. This will help people who were not born in Oakland County, or their parents were not married before a certain date.
- Dropbox for Sharing Documents
  - Jason discussed the drop box to share documents and resources for SOS to make sure everyone is on the same page. Right now it is set up for about 15 people to access documents, but could be set up to be accessed by a larger population.

### Other Issues/Updates

- Jason discussed hosting a webinar to give updates and present on different programs. They would host the same webinar on different days & times so everyone could access the webinar.

**Social Security, Dan Bowman, SSA**

- It is now national policy for SSA to accept an HMIS ID card as an alternate (3<sup>rd</sup> priority) proof document when an individual does not have a state ID/DL. (A State ID/DL or passport are primary proof documents.) Dan also indicated that the new corrections ID may also be added in the future as an accepted document. While the policy has been rolled out, trainings will be taking place in 22 field offices in Southeast Michigan. The client does not need proof that all forms of ID are not accessible. A state ID or passport that is expired 5 years or less should be replaced by SoS. **Refer to the attached document that describes the acceptable forms of identifying features of Identification.**
