Good afternoon.

The Circuit Court and County Clerk's Offices are requesting an eVote approval to move forward with the Statewide eFiling System Upgrade project sized at 1,211 hours. The Michigan State Court Administrative Office has selected ImageSoft to provide the platform for eFiling statewide. This mandate requires a migration for the 6th Circuit Court from the current Tyler eFiling system to ImageSoft's TrueFiling System by December of 2017. Based on discussion at the August LG meeting, recommended priority for this project is the new #6 in the Courts 2017/18 Master Plan. Proceeding by eVote was approved at the meeting, so it is not necessary to vote on that issue here.

The funding required for the 1,211 IT labor hours has been approved by the BTF and is available in the non-departmental General Fund for IT Development.
