The County Clerk's Office is requesting an eVote approval to move forward with the eFiling System Upgrade project sized at 846 hours. This project is to upgrade the Tyler eFiling system to the latest software version due to the current OC version being end of life and non-PCI compliant. The vendor has indicated that they will no longer support the OC software version as of March 2017. The project has been estimated at 846 hours and will be a **funded project**. The recommendation is to prioritize the project as the new #5 under the last **funded/mandated** project in the Courts MP.
