The Courts Justice Administration (Clerks/Vital Records) is requesting an eVote approval for 100 hours to be added to the Mandates EB to execute deliverables related to the Office of the State Registrar no longer providing forms for Marriage Licenses and Affidavits. There are 358 hours in Courts Unallocated right now.

As of 2/26/2020 the State is providing a pdf for the Registrar's Office to populate and integrate into their software. This request will provide hours for the State provided Marriage License and Affidavit PDFs to be integrated with the Vital Records Management System and printed with populated data. This change is in effect immediately as the State is no longer providing forms. In order to proceed in a timely manner, we will need the hours from Unallocated within the Courts/Justice Administration Leadership Group.
