Good afternoon. I have a new request regarding unallocated hours. We already approved the use of the e-vote for this purpose at our July meeting, so you only need to vote on the specific question below.

Children's Village is requesting an eVote approval of 210 hours to proceed with the RFP project for a replacement to their existing Case Management application. 130 hours of the project will be provided by the Children's Village Enhancement Budget. The remaining 80 hours will be provided from Unallocated hours in the Courts/Justice Administration Leadership Group.
